ANNOUNCEMENT SMAC 3
(Sale of Miscellaneous Agricultural Commodities)
Invitation No. 5 - Cotton

The Commodity Credit Corporation (CCC) invites offerors to purchase Cotton in-store in accordance with the terms and conditions of Announcement SMAC 3, path provided below, please copy and paste into your browser.

CCC-owned cotton inventory information may be obtained from CCC's catalog listing, which is attached to this Invitation.

CCC-owned cotton will be sold and released in-store at the warehouse location listed in the catalog using the factors shown on the warehouse receipt(s). Warehouse operators are obligated to deliver the specific bales in the identified lot. CCC will not pay the loadout charges. Prior to submitting a bid, offerors (buyer) are advised to check with the storing warehouse operator regarding scheduling and any applicable charges. The offeror will be responsible for any of these applicable charges.

Offerors will be required to enter a per lot bid, U.S. Dollars per pound, with no more than four decimal places. Regardless of size, lots must be bid on in their entirety. Each bid will be analyzed independently, and no offer can be contingent upon the acceptance of other offers. CCC reserves the right to reject any or all offers.

CCC will pay storage through the date of the contract. The buyer is responsible for paying loadout charges plus storage charges incurred from the day after the date of contract. The date of contract is the date the offeror is notified by CCC that their bid is successful.

Buyers of cotton must remit to CCC the payment equal to 100% of contract value within five business days after the date of contact. CCC will transfer title of the cotton (in-store) upon receipt of payment. If payment is not received within five business days of the contract date, interest will accrue for the account of the buyer on the sixth business day and continue up to the date payment is received by CCC. It is not acceptable for a buyer to withhold payment in favor of continuing to pay interest to CCC.

Offers and any modifications, or withdrawals of offers must be received in the Kansas City Commodity Office (KCCO) by 12 p.m., Central Time (CT), February 26, 2019.

Successful offerors will be notified of acceptance by telephone or email by 3:00 p.m., CT, February 27, 2019.

Upon an award, the buyer must obtain a holder ID, if the buyer does not already have one, which may require a minimal fee and sign an agreement with EWR, Inc. (Electronic Warehouse Receipts). **The web-site is ewrinc.com.**

SUBMISSION OF OFFERS

How to Submit Offers

(1) Offers, modifications, withdrawals, and cancellations shall be submitted by the following method.

(2) Attached Offer Form CCC-331D (Cotton) must be completed and signed. Instructions are attached to the Offer Form. Reproductions of the offer form are acceptable.

Where to Submit Offers

(1) Offers, modifications, withdrawals, and cancellations of offers shall be submitted to the Kansas City Commodity Office (KCCO) and must be received by the date and local time specified in this invitation for receipt of offers.

Transfer of title to successful offeror will occur upon receipt of payment and the cotton is released by the Commodity Credit Corporation.
